



**CLEAR CREEK ISD BOARD OF TRUSTEES
CITIZEN OF THE YEAR AWARD
NOMINATION FORM**

The Clear Creek Independent School District Board of Trustees has established an endowment to honor outstanding community members within Clear Creek ISD. The recipient of the award will be named as the Citizen of the Year. In addition, the recipient may designate endowment funds to a Clear Creek ISD academic program or classroom activity in his or her name.

AWARD REQUIREMENTS

1. **Criteria:** Recipients eligible for this award must meet the following requirements. The Citizen of the Year should have:
 - a. Demonstrated a commitment to Clear Creek ISD through volunteer or other extraordinary efforts.
 - b. Contributed significantly in ways that have benefited the entirety of Clear Creek ISD.
 - c. Maintained a reputation across the Clear Creek ISD community as an individual with high standards and dedication to excellence in public education.
 - d. Served the district and its students and patrons over an extended period of time.

2. **Process:** Please provide a description of how the nominee has met the criteria using the form on the next page. In addition to the information contained on the nomination form, you may provide no more than three additional pages of supporting documentation.
Applications that are late or that are incomplete will not be eligible for consideration.

3. **Recognition of the Citizen of the Year:** The recipient is expected to attend the award ceremony during the Clear Creek Education Foundation's "All-Stars Breakfast" on October 23, 2008.

4. **Recognition of a Clear Creek ISD Program or Activity:** Recipient is expected to designate a Clear Creek ISD academic program or classroom academic activity through the financial grant provided by the endowment. In addition, the honoree is expected to participate in awarding the funds to the recipient during the annual breakfast.

5. **All nominations must be submitted no later than September 1, 2008.** Nominations should be mailed to:
